1. GENERAL PROVISIONS

The purpose of the discipline " International food security

law" is to consolidate, expand and deepen special legal knowledge of the content of international legislation aimed at regulating relations in the field of food security, as well as the implementation of Ukraine's international legal obligations in the national legal order. The study of this discipline will enable students to master the basic categories of international International food security law, understand the patterns of legal regulation, and acquire practical skills in the field of food security at the national and global levels, promote the development of skills of independent analysis and interpretation of international legal documents in this area, and ensure the intensification of students' analytical activities and research work. The study of the discipline "International food security law" is an important component of the training of a modern lawyer capable of providing qualified legal assistance in the field of international legal support for food security.

The proposed course of the discipline is aimed at the implementation of the qualification training of masters who have fundamental legal knowledge in the field of public international law, European Union law and legal regulation of agricultural relations in the field of food security.

The objectives of the discipline "International food security law" are

- Formation of students' professional and subject competencies based on scientifically based concepts and doctrines, understanding of the basics of international legal regulation of relations to ensure food security;
- development of skills to determine the specifics of legal relations arising in ensuring food security at the international level;
 mastering the skills of determining the specifics of international legal regulation of certain relations related to food security, as well as systematization and classification of its levels, threats, criteria and indicators;

- developing the ability to analyze international legal documents in the field of food security, to substantiate an independent point of view on a particular problem related to food security or the main directions of further development of its international legal regulation, based on the rules of law.

The forms of organization of the educational process in the discipline "International food security law" are classes; independent work; practical training; control measures. Types of classes are: lectures, practical classes, individual classes, consultations under the guidance of teachers.

The purpose and objectives of the discipline "International food security law" are realized in the topics of practical classes, which consistently reveal theoretical concepts, regulations and legal institutions that are inherent in legal relations to ensure food security and reflect their specifics.

The fulfillment of these tasks and achievement of the purpose of the discipline "International food security law" involves the active work of students in the study of recommended literature, regulations, international legal acts, organization of work of international, intergovernmental organizations, periodicals and case law.

As a result of studying the discipline "International food security law", students should

- know and understand the state and main problems of the science of International food security law on the following issues: system-forming categories of International food security law, their essence; universal and specialized international organizations as subjects of food security at the global and regional levels; international legal regulation of food security within the World Trade Organization; legal framework for ensuring food security in the EU, the EU Common Agricultural Policy; international legal regulation of food security in military zones; international legal regulation of the quality and safety of agricultural products as a basis for ensuring food security, production and circulation of organic food; basics of international legal support for biosafety in food production; legal support for food security in the United States, Canada, Japan; legal framework for solving food problems in Africa and Latin America.
- be fluent in the system of International food security law;

- be able to analyze the criteria and indicators of food security, identify threats to food security and choose ways and means to overcome them; apply the rules of law in the field of safety and quality of agricultural products as the basis of food security; select and summarize legal acts regulating relations in the field of food security in order to critically and constructively evaluate them; draw up legal documents in ensuring food security; assess legal situations and formulate new hypotheses and solve scientific problems in the field of International food security law; argue their own point of view regarding the decision made on a specific task. Assessment of students' knowledge of the discipline "International food security law" is carried out during the semester based on the results of the current (module) control and final control. The final form of control is a test based on the results of practical classes.




Task 3

The highest governing body of the WTO is the Ministerial Conference, which usually meets every two years. Below it is the General Council (usually ambassadors and heads of delegations in Geneva, and sometimes officials sent from member capitals), which meets several times a year at the headquarters in Geneva. The

General Council also meets as the Trade Policy Review Body and the Dispute Settlement Body.

At the next level are the Council for Goods, the Council for Services and the Council for Intellectual Property (TRIPS), which report to the General Council. Numerous specialized committees and working groups deal with individual agreements and other areas, such as environment, development, membership applications, and regional trade agreements. All WTO members can participate in all councils and committees, except for the Appellate Body, dispute settlement panels and multilateral committees.

Familiarize yourself with the WTO's organizational chart and structure and describe each level of the organization, including its powers and functions.



Task 4

Dispute settlement is a central pillar of the multilateral trading system and a unique contribution of the WTO to the stability of the global economy. Without dispute settlement, the WTO would be less effective because the rules could not be enforced. The WTO procedure emphasizes the rule of law, is transparent and predictable, based on clearly defined rules with a timetable for the completion of the case. The first decisions are made by the panel and approved (or rejected) by the full WTO members. Appeals based on questions of law are possible.

Disputes in the WTO are essentially unfulfilled promises. WTO members agree that if other members violate trade rules, they will use the multilateral dispute settlement system instead of acting unilaterally. This means following agreed procedures and respecting decisions.

A dispute arises when one country adopts a trade policy measure or takes certain actions that one or more WTO members consider to be a violation of WTO agreements or a failure to fulfill obligations. A third group of countries may declare that they have an interest in the case and enjoy certain rights.






IDENTIFYING SIX DIMENSIONS OF FOOD SECURITY IN ITS CURRENT DEFINITION



Availability	Having a quantity and quality of food sufficient to satisfy the dietary needs of individuals, free from adverse substances and acceptable within a given culture, supplied through domestic production or imports.
Access (economic, social and physical)	Having personal or household financial means to acquire food for an adequate diet at a level to ensure that satisfaction of other basic needs are not threatened or compromised, and that adequate food is accessible to everyone, including vulnerable individuals and groups.
Utilization	Having an adequate diet, clean water, sanitation and health care to reach a state of nutritional well-being where all physiological needs are met.
Stability	Having the ability to ensure food security in the event of sudden shocks (e.g. an economic, health, conflict or climatic crisis) or cyclical events (e.g. seasonal food insecurity).
Agency	Individuals or groups having the capacity to act independently to make choices about what they eat, the foods they produce, how that food is produced, processed, and distributed, and to engage in policy processes that shape food systems. The protection of agency requires socie-political systems that uphold governance structures that enable the achievement of FSN for all.
Sustainability	Food system practices that contribute to long-term regeneration of natural, social and economic systems, ensuring the food needs of the present generations are mel without compromising the food needs of future generations.

Between July 2021 and June 2022, China accounted for 90 percent of Japan's ammonium phosphate imports, and the United States for 10 percent. Alternative suppliers of ammonium phosphate near Japan are limited. Canada accounted for 59 percent of Japan's potassium chloride imports, followed by Russia for 16 percent, and Belarus for 10 percent. Japan imported 47 percent of urea for fertilizer use from Malaysia and 37 percent from China. Even if the supply from Russia decreases and global supply becomes tight, MAFF believes that Japan will be able to import urea from other suppliers.



It was created as a structure responsible for the implementation and involvement in the management of national food and nutrition security policies at the federal, state and municipal levels. Currently, SISAN is composed of inter-ministerial (or intersectoral) chambers of food and nutrition security (CAISAN) and food and nutrition security councils (CONSEA) operating at the federal, state and municipal levels.

5. INDEPENDENT WORK OF HIGHER EDUCATION STUDENTS

Independent work of students is a component of the educational process, the main means of mastering educational material in extracurricular time.

The purpose of independent work of students in the discipline "International food security law" is to fully master the curriculum and form independence as a personal trait and an important professional quality, the essence of which is the ability to systematize, plan and control their own activities. The general task of students' independent work in the discipline "International food security law" is to intensify the analytical activities of students, develop the skills of independent analysis and interpretation of legislation, conduct research, and practical skills in this area. Independent work of students ensures their preparation for current practical classes and exams.

The content of students' independent work in the discipline "International food security law" is determined by the curriculum of the discipline and other teaching materials, and its scope is determined by the teacher who organizes and supervises students' independent work.

The teacher determines the part of the material that is allocated for independent study, informs students, recommends the use of specific sources and forms of work with them. Control over the independent work of students is carried out in practical classes,

in the process of individual counseling and in the process of current control.

Independent work is carried out in the following forms:

- preparation of individual final written work;
- studying lecture notes;
- preparation of solutions to situational tasks;
- studying the main literary sources and regulatory framework;
 - drafting of procedural and law enforcement documents;
 - finalization of lecture materials;
- studying and summarizing additional literary sources and electronic publications;
 - work in information networks;
 - preparation for a business game, discussion;
 - completion of practical tasks, self-testing;
- participation in the work of the student scientific club, preparation of scientific reports and their presentation;
 - participation in student scientific conferences;
 - writing scientific articles and abstracts;
- participation in the All-Ukrainian competition of student research papers;
- Participation in Olympiads, tournaments and other competitive events;
- generalization, judicial and expert practice in accordance with certain topics;
- preparation of a portfolio (thematic portfolio of literary sources and publications, portfolio of regulations, portfolio of laboratory work, etc.)
- completion of homework in accordance with the curriculum, preparation for practical classes;
 - preparation of thematic multimedia presentations;
 - work on the recommended materials of legal practice;
- Preparation for the test in accordance with the list of questions;
 - work on cases.

6. CURRENT AND FINAL CONTROL OF STUDENTS' KNOWLEDGE

Evaluation of the results of mastering the discipline "International food security law" involves current and final control and is carried out on the basis of a cumulative point-rating system.

Current knowledge control includes:

- control of the quality of students' mastering the program material of the discipline in practical classes using the following means: oral, written or express survey, solving practical problems or tasks, participation in the development of a case, preparation of a thematic presentation, defense of an essay or abstract on the initiative of the student. The current control is aimed at checking the level of student's preparation for the study of the material. During a practical lesson, a student can receive a grade from 0 to 5 points;
- quality control of students' mastering of the program material of the discipline, which is carried out at the end of the modules in the form of colloquia, testing on a particular section (topic) or on certain issues of the course. At the end of the semester, a written test is conducted on a grading scale from 0 to 15 points.

During the semester, students complete tasks for independent work (preparation of a presentation, poster, essay, abstract, scientific article, scientific report/speech to a scientific club, etc.) The maximum number of points for independent work is 20 points.

The performance of control work and independent work is a mandatory component of the final grade in the discipline.

The form of final control of knowledge of higher education students in the discipline is a test based on the results of practical classes. The maximum number of points a student can receive for a test is 100 points. The minimum score for the results of current control and independent work, with which a student is allowed to take the test, is 60 points.
