The relationship between national constitutionalism and European constitutionalism through the prism of national (constitutional) identity. The concept and system of modern constitutionalism.

Fundamentals of constitutional theory. The concept of a constitution and its legal properties. Classification of constitutions. Functions of the constitution. General characteristics and purpose of modern constitutions. Legal protection and defense of the Constitution of Ukraine. The concept of protection and defense of the Constitution of Ukraine. Forms of protection of the Constitution of Ukraine. Features of amending the Constitution of Ukraine. Constitutional control as a form of protection of the Constitution of Ukraine. Lustration measures as a form of protection of the Constitution. Prohibition of the activities of political parties as a form of protection of the Constitution: legal nature and procedure for application. Constitutional and legal responsibility in the mechanism of protection of the Constitution of Ukraine. Responsibility of public authorities in the EU member states (transparency, accountability, compliance with anti-corruption legislation, etc.).

Constitutional law of Ukraine as the basis of national law. Constitutional law as a leading branch of law. Concept, subject and method of constitutional law of Ukraine as a branch of law. Sources of the branch of constitutional law of Ukraine. Formation of European constitutional law. Sources of law of the European Union, their relationship with national sources of law, acquis

Constitutional and legal norms, their classification and features. Constitutional and legal institutions, their types. Constitutional and legal relations and their structure. Main stages of development of Ukrainian constitutionalism. Constitutional reform of 2004. Constitutional reform of 2016. Reform of the Constitution of 2019 regarding the European and Euro-Atlantic course. European reservation and membership in the EU: experience of European countries. Prospects for updating the Constitution of Ukraine and national legislation with the aim of Ukraine's accession to the European Union. The constitutional process at the current stage.

Module 2. The constitutional system of Ukraine and its basic principles.

General characteristics of the constitutional system of Ukraine and its basic principles . The concept of the constitutional system of Ukraine. Features of autonomy in a unitary state. Legal status of the Autonomous Republic of Crimea. Constitution of the Autonomous Republic of Crimea. System of authorities of the Autonomous Republic of Crimea and their competence.

Constitutional principles of local self-government . The principle of guaranteeing local self-government. The concept of local self-government and its system. Features of the implementation of local self-government at the level of the region (district) and at the level of territorial communities. 5. Forms of pedagogical control and means of assessing learning outcomes

Assessment of the results of mastering the academic discipline " Financial Law " involves conducting current and final control and is carried out on the basis of a cumulative point-rating system.

Current knowledge control includes:

- quality control of students' mastery of the program material of the academic discipline during *practical classes* using the following means: oral, written or express survey, solving practical tasks or problems, participation in the development of a case, defense of an essay or abstract at the initiative of the student. Current control aims to check the level of preparation of the student for studying the current material. During the practical class, the student can receive a grade on a four-point scale (0, 3, 4, 5);
- quality control of students' mastery of the program material of the academic discipline, which is carried out at the end of the modules in the form of a test or colloquiums;
- students complete tasks for *independent work during the semester* (preparation of a presentation, essay, abstract, etc.). The maximum number of points for independent work is 8.

The form of *final control* of knowledge of higher education applicants in the academic discipline is an exam. The maximum number of points that a student can receive for the exam is 60. The minimum score of the results of the current control and independent work, which allows a student to take the exam, is 25 points.
